Drag-and-Drop Data Import

Simply drag and drop data into the user interface. NightHawk automatically identifies and imports relevant information, eliminating the need for manual extraction and parsing.



Intersect Tool

Analyze digital activity across time and location to reveal hidden connections between suspects, such as shared addresses, contacts, messages, and more.



Subject Interaction Filtering Tool (SIFT)

Chronologically scroll through calls, messages and events across media types to follow full conversations alongside sensor and location data (e.g., GPS, gunfire acoustic identifiers, license plate readers).



Secure, Real-Time Collaboration

Grant controlled access for real-time information sharing across agencies, enabling simultaneous updates and actionable intelligence.



Dynamic Timeline and Map Visualization

Integrated data is displayed on a linked, interactive timeline and map. Zoom in and out on times and geographic areas of interest. Visualizations are linked and updated automatically based on user selections and analytic functions.
